I'm hoping for your input here. There's a question heavy on my mind right now.
.[size=14pt] Q: What's the proper flavor of hadracha (guidance) to give a young person who's part of the Forum?[/size]
You see, I generally assume the members (AND the unregistered "lurkers") are all "of a certain age." You know: legal adults, past the initial rushes of puberty, self-aware of who they are and what they stand for, etc etc. Most of us are. And I post with that in mind.
Still, younger folks are part of the Forum, too. They may have a real "addiction" issue, or may just be red-blooded frum teens trying to reconcile G-d's dual gifts to them of His Torah and an adult body. They might be so young that it's inappropriate (or even illegal?) to chat with them in the way we'd chat with an older member.
So, my question in more detail becomes stuff like:
1) Should we assume that any teen who found GYE has a serious lust issue, or should we reassure them that some challenge is perfectly normal?
2) Are there limits in the postings etc we make to them (like suggesting that one mz'l brings gehinnom, or promoting SA)?
3) Should we censor our posts to other adults because teens could be listening?
4) What's the right age for us to stop worrying about their age?

But talking with teens about topics like acting out, I've seen every view possible on the site. As to adults saying stuff that might not be right for teens to read:

TRAGIC INFO.

One adult says he acted out in his youth. He then said it was mzl two times in his LIFE. Yet he said it brought him to long-term suicidal depression. Wow. What kind of message is THAT for a teen. [Heck, in my youth I'd go two times in an HOUR.]

HURTFUL INFO.

One adult told a teen that even one case of acting out leads straight to gehinnom with no possible tshuva. [Well, boys, if true I think we'll be meeting a lot of people down there (Ch'V)... didn't Dovid haMelech call this the "sins of our youth?"]

TOO MUCH INFO.

Then there's the question of replying to a teen with possibly TMI "too much info". Should an adult be saying on a teen's thread, I don't know, when he started acting out or what specific

activities got him in trouble? Or asking for very personal details from the teen? Maybe teens need/deserve a higher level of tznius than older members, at least in their own threads. I DON'T KNOW, and I'm hoping other members will chime in.

I remember you saying that you're 15. I'm sure you think you can handle anything in this department. I'm thinking, though, that some folks (not ME, of course!!!!) have background that you might be ok to read but shouldn't necessarily have as part of advice directed straight at you. TMI.

And then there's the fact that some countries and states have laws about sex-related communications with young people. Even, perhaps, when the motive is therapeutic and not lewd. I have no clue if any of the laws would ever apply, but all we need is the chillul Hashem of GYE ending up in a headline somewhere. [Or in some darned British court of "int'l jurisdiction" raising a crime against humanity] But now I'm going overboard.
